Discontinuation of data supply on EC 2623 / First Metro Investment Corp., Philippines

Due to new regulations of the Philippine Dealing Exchange System the data supply for Bonds on EC 2623 has discontinued effective 7 July 2008. At present no alternative data supplier is offered. The exchange code 2623 will be deleted with immediate effect.

6.1 Migration of special and big investor funds of OeKB from EC 2602 to EC 2915

Big investor funds and special funds of Oesterreichische Kontrollbank OeKB will be **migrated to and entitled separately on EC 2915, effective 11 August 2007**. With this these funds can better distinguished from public funds. The public funds remain on EC 2602. A parallel run will be maintained on both exchange codes until 8 September 2008. 8. **Reminder of former pre-announcements**

8.1 **Extended format Swiss Valoren number**

The systems at Telekurs issuing the Swiss Valoren numbers will be modified in the way that after they have reached number CH: 4'999'999, they will switch to CH: 10'000'000 and start assigning 8-digit Swiss Valoren numbers. This modification is expected to take place in the 4th quarter of 2008. In view of the future, we recommend not to limit the numbers exactly to 8 digits, but to opt for a format of 9 characters. 9 characters correspond to the basic number of the ISIN.
