6.2 Migration / Change of the non traded funds on EC 13 to separate exchange codes

The non traded funds on EC 13 will be moved to separate exchange codes (2667, 2668, 2671 - 2678, 2680 - 2682) in order to show the origin of the data and the non traded character of the funds. This dislocation is scheduled for **14 August 2006**. A parallel run on EC 13 will be provided until 13 October 2006. An instrument list will be available in June.

8.1 **Implementation of the market depth – Swiss Stock Exchange – EC 4, 349, 351, 252, 504**

The implementation of the market depth (2nd – 10th best bid and ask quotes) had to be postponed until further notice due to technical reasons.

8.2 **Currency reform in Mozambique effective 1 July 2006**

A currency reform will be carried out in Mozambique effective 1 July. The current currency description will be changed from Metical MZM to Metical MZN.

8.3 **Change of the security code for national currencies**

The Swiss fiscal prices (EC 200) will continue to be delivered on instruments of security type B (11) until further notice.
