6. **Pre-announcement**

6.1 **Introduction of fees for U.S. securities numbers by Standard & Poors's (S&P)**

Standard & Poors (S&P), issuer of the US securities numbers CUSIP for American firms, will be introducing a charge effective **1 July 2006 for the use of CUSIP data inclusive ISIN's** (MDF+2 and Telekurs iD). A more detailed customer letter will be mailed shortly.

6.2 **Change of the security code for national currencies**

In future, the security code B (11) „national currencies“ will only be used for instruments with Swiss fiscal prices (EC 200 / tax authorities).

All other instruments with quotes for national currencies, having presently security code B (11), will be changed to security code X (33 technical valoren). This reorganization takes place in September 2006, the exact date is yet to be defined.

8. Reminder of former pre-announcements

8.1 Change of the processing of the 3-months metal contracts of London Metal Exchange

At present the quotes and spreads of the 3-months metal contracts are being processed on two separate security codes (Swiss valoren numbers).

8.2 Implementation of the market depth – Swiss Stock Exchange – EC 4, 349, 351, 252, 504

Swiss Stock Exchange will implement the market depth (2nd – 10th best bid and ask quotes) effective 22 May 2006.

8.3 Currency reform in Mozambique effective 1 July 2006

A currency reform will be carried out in Mozambique effective 1 July. The current currency description will be changed from Metical MZM to Metical MZN.
