6.2 Change of the security type for Real Investment Trust (REITs) from 7 and C to 1

The panel of experts made up of members of the Swiss Federal Tax Administration, the Swiss Bankers Association, several banks and Telekurs Financial has analysed in detail how taxes for Real Investment Trusts (REITs) are handled. It turned out that assigning security type 7 "Trust Shares" and C "Trust cert.unit/fund, invest. Foundation units" to the relevant instruments is no longer sufficient.

Particularly in view of the EU Savings Tax, it is necessary to change the security type.

As resolved and specified by the Swiss Federal Tax Administration and following the usage in the German and Anglo-Saxon markets, the corresponding **instruments with security types 7 "Trust Shares" or C "Trust cert.unit/fund, invest. Foundation units" has been reorganized to 1 "Share, unit, participation cert." effective 6 November 2007**. An instrument list (Reits_affectedinstruments) can be provided upon request.

6.3 SWX / Migration from EC 349, 351, 352 to EC 4

8.1 Extended format Swiss Valoren number

The systems at Telekurs issuing the Swiss Valoren numbers will be modified in the way that they will switch to CH: 10'000'000 and start assigning 8-digit Swiss Valoren numbers. This modification will take place at the latest in mid 2008. We recommend not to limit the numbers exactly to 8 digits, but to opt for a format of 9 characters in view of the future. 9 characters correspond to the basic number of ISIN.
